

Register of Members' Interests - WYBUNBURY Parish Council

Under the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012 and Cheshire East Council's Member Code of Conduct, as an elected or co-opted member of WYBUNBURY Parish Council; you must register your own disclosable pecuniary interests, as a defined in the six categories set out below, together with those of your spouse or civil partner (or a person with whom you live as a spouse or civil partner) of which you are aware.
